A portion of your 2021 dues to the FHBA is used for lobbying and is not deductible for tax purposes. The non-deductible portion of your 2021 FHBA dues is 28% and the non-deductible portion of your 2021 NAHB dues is 19%.

\$10.00 of your dues for membership in the Florida Home Builders Association and One Dollar (\$1.00) of your dues for Bay Building Industries Association is allocated to the Florida Home Builders Political Action Committees. This portion of your dues is not tax deductible as a business expense.

This allocation is optional. If you do not want any of your dues allocated to FHBA Political Action Committee, please indicate so and this allocation will be retained in FHBA operating funds.
